❖ LED is recommended for reflow soldering and soldering profile is shown below.

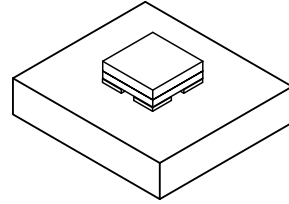
❖ The device has a single mounting surface. The device must be mounted according to the specifications.

Reflow Soldering Profile for SMD Products (Pb-Free Components)

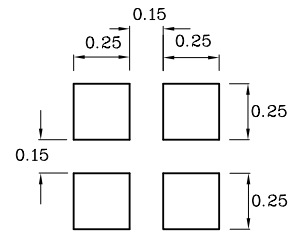


Notes:

3. Maximum number of soldering passes: 2



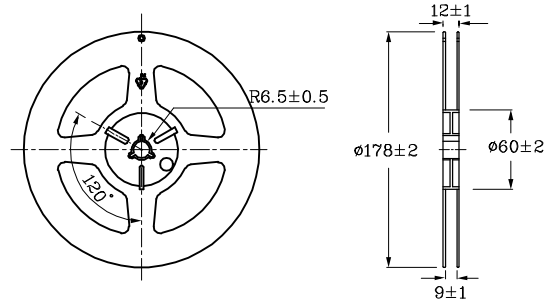
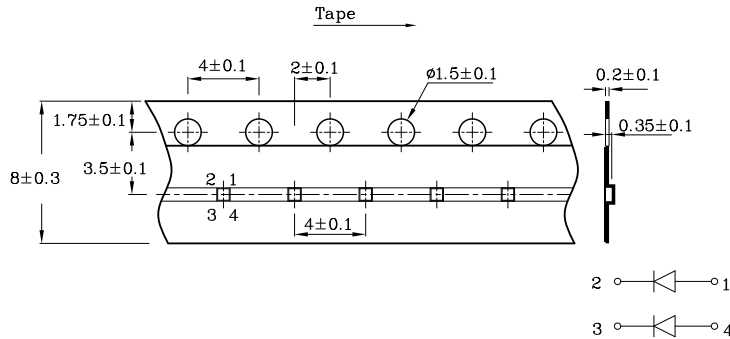
❖ Recommended Soldering Pattern (Units : mm; Tolerance: ± 0.1)

Remarks:

If special sorting is required (e.g. binning based on forward voltage, Luminous intensity / luminous flux, or wavelength), the typical accuracy of the sorting process is as follows:

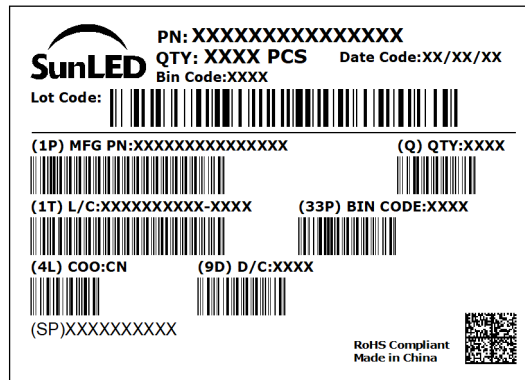
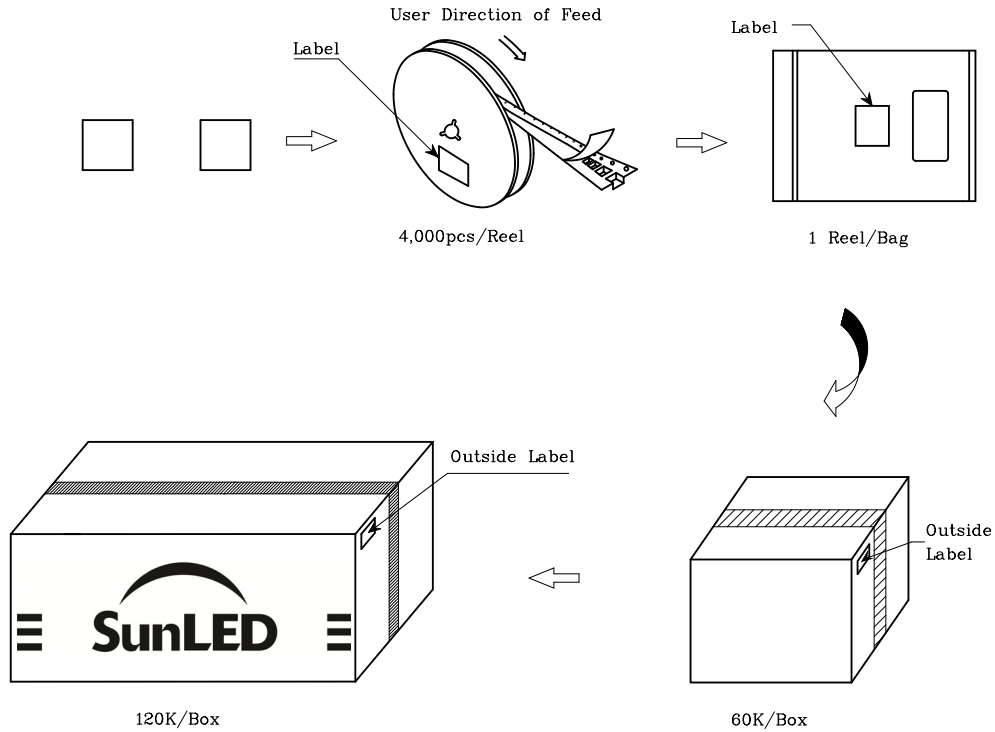
1. Wavelength: +/-1nm
2. Luminous intensity / luminous flux: +/-15%
3. Forward Voltage: +/-0.1V
4. Within 35mW when multiple chips are lightened
5. The maximum ratings are valid for the case of lighting a single chip

When two chips are lit at the same time, each chip should be driven at a current lower than 50% of the absolute maximum ratings

6. Duty Cycle ≤ 1/20, Pulse Width=1ms.

Note: Accuracy may depend on the sorting parameters.
